NOTICE ON THE PROCESSING OF PERSONAL DATA

(ART. 13 REGULATION EU 2016/679)

Dear Student,

For the purposes set out in the above-mentioned EU Regulation 2016/679 (hereinafter the “G.D.P.R. 2016/679”) and in the recent Privacy Code, containing the new provisions for the protection of “privacy” and relating to the protection and processing of personal data, you are informed that the personal data already provided by you and processed by ADSU are processed for ADSU's institutional purposes in relation to the services referred to in Regional Law (L.R.) 91/94.

The processing of personal data is carried out in compliance with the obligations of confidentiality, fairness, lawfulness and transparency, and through the implementation of logical, physical and legal safeguards.

DATA CONTROLLER

PURPOSE OF PROCESSING

The personal data processed and provided by the data subject are necessary for the administrative and financial management of scholarships.

METHODS OF PROCESSING AND STORAGE

The processing of the data you have provided is carried out both in automated and manual form, in compliance with Art. 32 of the G.D.P.R. 2016/679, by specifically appointed persons and in accordance with Art. 29 of the G.D.P.R. 2016/679. Please note that, in compliance with the principles of lawfulness, purpose limitation and data minimization set out in Art. 5 of the G.D.P.R. 2016/679, and subject to your free and explicit consent expressed in the attachment to this notice, your personal data will be stored for the period of time necessary to achieve the purposes for which they are collected and processed, and in any case not beyond the terms established by tax, labor and social security regulations and by the Civil Code on the matter, plus a further ten years.

SCOPE OF COMMUNICATION AND DISSEMINATION

We also inform you that the data collected will never be disseminated and will not be subject to communication without your explicit consent, except for the necessary communications that may involve the transfer of data to public bodies, consultants or other parties for the fulfillment of legal obligations. Furthermore, such data may be

accessed, within the limits of current legislation, by employees and/or collaborators expressly appointed by the Data Controller.

SPECIAL CATEGORIES OF PERSONAL DATA

Pursuant to Articles 9 and 10 of the G.D.P.R. 2016/679, you may provide our organization with data classified as “special categories of personal data”, namely data revealing “racial or ethnic origin, political opinions, religious or philosophical beliefs, or trade union membership, as well as genetic data, biometric data intended to uniquely identify a natural person, data concerning health or a person's sex life or sexual orientation.” Such categories of data may be processed only with your prior and explicit consent, given in writing in the attachment to this notice.

RIGHTS OF THE DATA SUBJECT

In relation to the data covered by the processing referred to in this notice, the data subject is recognized, at any time, the right to:

- Access (Art. 15 Regulation EU no. 2016/679);
- Rectification (Art. 16 Regulation EU no. 2016/679);
- Erasure (Art. 17 Regulation EU no. 2016/679);
- Restriction of processing (Art. 18 Regulation EU no. 2016/679);
- Portability, understood as the right to receive from the data controller the data in a structured, commonly used and machine-readable format, in order to transmit them to another data controller without hindrance (Art. 20 Regulation EU no. 2016/679);
- Objection to processing (Art. 21 Regulation EU no. 2016/679);
- Withdrawal of consent to processing, without prejudice to the lawfulness of the processing carried out on the basis of consent given before the withdrawal (Art. 7, para. 3 Regulation EU no. 2016/679);
- Lodging a complaint with the Data Protection Supervisory Authority (Art. 51 Regulation EU no. 2016/679).
